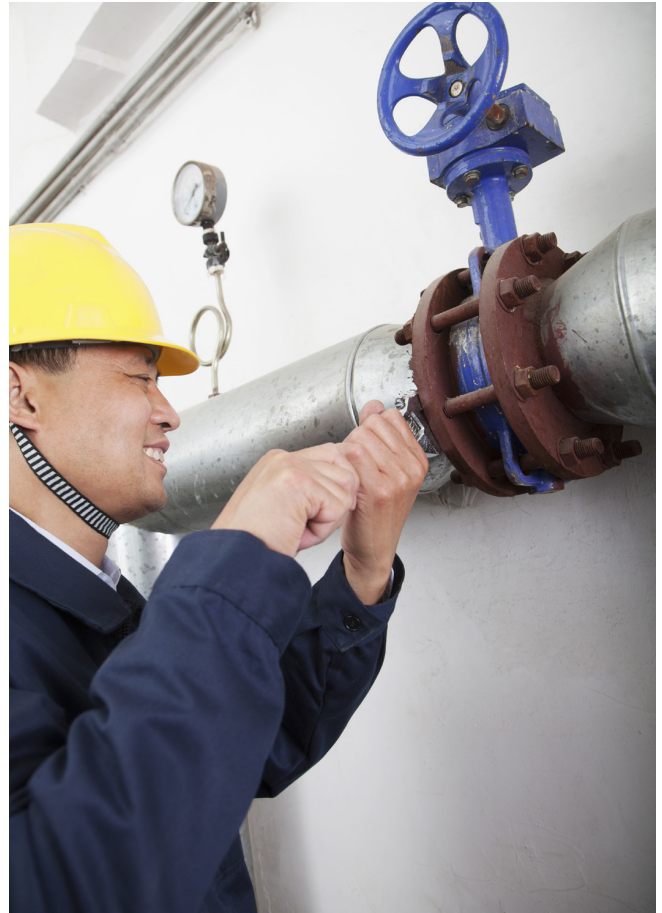
## Who We Are

- » Emergency planning, including contagious disease planning
